- To share/communicate a thorough working knowledge of relevant legislation, national standards, guidance, research, departmental policy and procedures.
- To provide quality assurance and coaching/mentoring to work colleagues.
- To take a 'joined-up' approach to achieving optimal outcomes for children and young people, actively promoting/encouraging effective partnership working with service users and other teams/agencies/organisations.
- To participate in the regular collection, collation and reporting of appropriate performance management information in accordance with statutory and organisational requirements
- To participate in adopter training and development activities.
- To promote a culture of learning and evidence and relationship-based practice.
- To represent the RAA in meetings etc as required
